The Chairperson welcomed all the members to the 55th meeting of the Governing Body of the University College of Engineering (A), OU, and requested the Principal to initiate the proceedings.

The Principal gave a brief appraisal on the following before taking up the items of the Agenda:-

- 55.1 The Principal appraised / informed the members that the TEOIP-III, has been accorded a score of 1.12 on the scale of 1 to 3, based on the Performance Audit conducted in the month of August, 2019. During the last Performance Audit a score of 1.27 on the scale of 1 to 3 was given.
- 55.2 That our college has been recognized as one of the Best Performing Institutes under TEQIP III and also as one of the top ten colleges in India. In view of this, an additional grant of Rs. 1.40 Crore was sanctioned and Rs. 70.00 Lakhs has been released to the College.
- 55.3 With the introduction of AICTE Model Curriculum from 2018-2019 at UG level, there is rise in internship.
- 55.4 Apart from 3 SERB Projects already on hand 4th project is in progress, with a total sanction of Rs. 200 lakhs and a SPARC project of Rs. 75.00 lakhs. Further, projects worth Rs. 450 lakhs are in the pipeline for sanction Prof. M. Kumar, Principal, also the Coordinator, is in touch with the Departments and sanction of various projects.
- 55.5 Dr. Sriram Venkatesh, Professor, Department of Mechanical Engineering, was chosen for the "Best Teacher 2019 Award".
- 55.6 Dr. G. Mallesham, Professor, Department of Electrical Engineering, was chosen the "Best Engineer 2019 Award".
- 55.7 Best Faculty Award 2019 was awarded to Dr. M. Kumar, Professor, Department of Civil Engineering and Principal, UCE (A), OU. He has been chosen continuously for the past three years.
- 55.8 Three weeks Induction Programme was conducted for the BE students admitted in the Academic year 2019-2020, one National Level Hackathon (12 hours) programme was conducted by Department of Computer Science & Engineering, which was sponsored by the TEQIP—III, as a Start Up Program. In view of the good response, the college is planning for "Hackathon" in other departments also after November 2019.

- 55.9 During 2019-2020 the placements at UG level is at 48.95% (141/288) and at PG level at 31.97% (47/147) and with a highest pay of Rs. 14.30 lakhs, at an average of Rs. 5.28 lakhs.
- 55.10 Activities of / in the Institution since last Board of Governors meeting:
 - (i) Principal & Vice-Principal interacted with department faculty at respective departments and also with Non-Teaching Staff.
 - (ii) Automation of Institution is under progress with around 6/8 modules completed. Now all receipts are automated with online payments.
 - (iii) The Department of Electronics & Communication Engineering could achieve 3 years NBA accreditation at the UG level i.e., for the period 2019-2022.
 - (iv) In the recent past i.e., September 2019 the College entered MoU with TIE GRAD (Indus Entrepreneurs, Hyderabad) which is a professional body, which motivates students to promote Start up entrepreneurship.
- 55.11 As a Startup project in the process of Automation 'tracking of student' is being introduced from this academic year 2019-2020.
- 55.12 The College Unit of NCC conducted (3) Camps continuously and NSS Conducted (8) programmes/activities, successfully NCC Unit of Institution received Best Tech Award 2019, this year. NSS conducted workshop on "Eat right Stay Fit" and also other society outreach activity.
- 55.13 Online courses MOOCs/NPTEL is being encouraged by the College.
- 55.14 About 40 no's IP based CC Cameras were installed in the Girls Hostel in August 2019.
- 55.15 Academic Council Meeting was held on 05th September 2019, and approved the AICTE Model Curriculum- Scheme & Syllabus in respect of PG Courses.
- 55.16 Two day workshop on "PYTHON Programming" was organized for the students of (4) departments in September 2019.
- 55.17 One day programme on (i) CANCER awareness was organized by Doctors of Apollo Hospitals, Hyderabad for the benefit of the Students & Staff (ii) Exhibition on Science & Spirituality was conducted by the Brahma Kumar's Foundation.

55.18 UG Tuition fee was increased from Rs. 9.750/- to Rs. 18.000/- from the academic year 2019-2020 – after a gap of about 15 long years.

The Chairperson, opined that there is need for the Institution / University to address a strong letter to the Government giving the reasons / justification for the enhancement of Tuition Fee every year @ 10% to 15%.

55.19 Aadhar based Bio-metric online attendance is successfully implemented for all the Teaching & Non-Teaching Staff.

Further, Bio-metric attendance for the students will be implemented very soon – as the TSPS has sanctioned 25 machines which would be installed @ one for each Class Room.

- 55.20 All the UG & PG Results were declared within (10) days from the last date of examination.
- 55.21 Swatch Bharat Programme is conducted regularly by the Institution.
- 55.22 The Institution / University entered into MoU with TSSPDCL during the month of July 2019.
- 55.23 Renovation of Wash Rooms were done at the cost of Rs. 5.50 lakhs. This task was completed by following the procedure of calling e-tenders.
- 55.24 The Institution organized Bathukamma Festival Celebrations.
- 55.25 Institution was Ranked: 83 by NIRF in 2019. The Process for NIRF 2020 submission is under progress.
- **55.26** All the departments are preparing for NBA pre-qualifier for 14 eligible P.G. Programmes.
- 55.27 It was proposed to the member of the Governing Body for the Construction of the New Hostel with 200 Rooms for Boys and 100 Rooms for Girls separately. The proposal with the plan / design, budget/estimates is being worked out.
- 55.28 Also proposed for the construction of the separate Hostel for the Research Scholars.

55.29 The Institution is always encouraging faculty to apply for Research Projects & Quality Publications.

55.30 The Institution is always encouraging students & faculty alike to apply for startups.

55.31 Plans to organize 60 Hrs "Employability Skill Programme" in the month of December 2019.

55.32 Plans to conduct/organize International Conference / Workshops / FDP's / Seminars.

55.33 Plans to conduct workshop on Digital Pedagogy & NBA accreditation process in November / December 2019.

55. Part - 'D' Review Items:

Item 23 – Presentation by the Heads of the Departments.

Bio-Medical Engineering:-

Prof. M. Malini, Head, Dept. of Bio-Medical Engineering, gave a Power Point Presentation on the Action Plan of the department for the next six months and also an overview of the achievements / awards / Seminars of the department in the recent past, and the patents obtained by the Department.

Civil Engineering:-

Prof. M. Gopal Naik, Head, Dept. of Civil Engineering, gave a Power Point Presentation on the Action Plan of the department for the next six months and also an overview of the achievements / awards / Seminars of the department in the recent past.

Computer Science & Engineering:-

Prof. P.V. Sudha, Head, Dept. of Computer Science & Engineering, gave a Power Point Presentation on the Action Plan of the Department, and also gave an overview of the events / achievements /awards etc., of the department in the recent past.

Electronics & Communication Engineering:-

Prof. P. Chandra Sekhar, Head, Dept. of ECE, gave a Power Point Presentation on the Action Plan of the department for the next six months and also an overview of the achievements / awards / Seminars of the department in the recent past.

Electrical Engineering:-

Prof. G. Mallesham, Head, Dept. of Electrical Engineering, gave a Power Point Presentation on the Action Plan of the department for the next six months and also an overview of the achievements / awards / Seminars of the department in the recent past. The Governing Body members advised to modify and send clear action plan for next six months.

Mechanical Engineering:-

Prof. P. Ramesh Babu, Head, Dept. of Mechanical Engineering, gave a Power Point Presentation on the Action Plan of the department for the next six months and also an overview of the achievements / awards / Seminars of the department in the recent past.

55. Suggestions / opinion by the Chairperson, Governing Body:

(A) "State of Art Technology" should be established in the College, which shall monitor & shall come up with some new innovative projects every six months, so that the College is vibrant in various aspects.

At this juncture, the Principal said there is a proposal namely "Innovation Cell" under active consideration for planning & development for likeminded faculty.

(B) Suggested that there should be procedure, which should be mandatory for the students of the College, to register themselves as "Alumni" as soon as they complete the course of study.

It was also suggested that there should be a method or a provision for the students to upgrade / update their CV / Resume as they grow.

By adopting such methods, he was of the opinion that it helps in encouraging the students and finding solutions for the "Industrial Hitch".

The above suggestion / opinion was given keeping in view the NBA feedback – wherein it was questioned about the track of students after completion of their study in the College, i.e., about their employment etc., with evidence.

(C) Retired teacher should be encouraged to work as a Adjunct Faculty by paying them, remuneration equal to the last pay drawn (-) minus their pension, so that the shortage of faculty problem can be overcome / solved to some extent.

(D) Each & every teacher /Faculty should be continuously "sensitized" in all the aspects not only when NBA Team visits, but should be a regular and continuous process. Each teacher should record their ideas and shall be put up on the web-site, department wise.

At this juncture, the Principal intervened and informed the members that the department of Electronics & Communication Engineering had applied for "Patent Certificate" for the project "Adjustable Heels".

- (E) The Chairperson, suggested to address the Government of Telangana i.e., the Principal Secretary to Higher Education and also the Chairman, TSCHE, the Commissioner of Technical Education, and seek clarification with regard to the recruitment of Teaching Faculty & Technical Staff in particular Lab-Assistants and as to how to overcome the crisis. It was also suggested to seek clarification as to whether these recruitments can be made through outsourcing agencies. He was of the opinion that we should be pro-active in this regard.
- (F) It was brought to the notice of the members of the Board of Governors, that there is a lot of paucity of time for the release of funds after the different projects are sanctioned i.e., SERB, DST-FIST etc., to the department / College, which leads to delay in progress of the project.

In this connection, it was suggested as to whether the College can release the funds, based on the sanction letter / orders of the projects, pending receipt of the amounts from the concerned agencies, in consultation by seeking clarification with the official Auditors of the College.

(G) During the course of the discussion, the Chairperson suggested that there should be a check and mechanism by which the contributions made by the outside Agency i.e., Individuals / Organizations, Alumni etc., for the development of the department / College is known.

These contributions & collections has to be monitored and updated at least once in every quarter of the year, along with the details of the purpose for which the contributions were received and the actual utilization etc.

It was opined that these aspects should be institutionalized and be brought to the notice of all the stake holders.

This accountability he suggested that, should be updated by the Head of the Department concerned regularly on the website or at least to come out with a News letter.

Further, the Chairperson was of the view that all the contributions must and should be brought to the notice / knowledge and should be spent with the permission of the Principal only.

The meeting ended with a vote of thanks and vice versa.
